## Conditions of Entry

1. The committee shall have the entire management of the tournament
2. The committee, in the event of bad weather, may either shorten or delay any contest or fix another date, and in the case of ties, shall decide the manner in which the result may be determined.
3. All events are only open to amateur golfers who are members of the Associate or Registered Golf Clubs of the GolfVic, or who are members of Golf Clubs outside the state of Victoria.
4. Competitions shall be played in accordance with the rules of golf as adopted by the Royal and Ancient Golf Club of St Andrews, Scotland together with such local rules that are in force on the course over which the competition takes place. If a dispute arises on any point the Committee in charge of the competition, whose decision shall be final, shall adjudicate it. However, the Committee, if in doubt, shall have the right to refer any such dispute to the Council of GolfVic.
5. Net event ties shall be decided by count back in accordance with the method recommended by GolfVic. Gross event ties shall be decided, if time permits, by play off. Should sufficient time not be available a count back will decide.
6. The committee shall have the right to accept, or refuse, the entry of any person without being required to give any reason for such acceptance/refusal.
7. Minimum of 3 entries per event. The committee reserves the right to combine entries and create a new event where minimum numbers are not exceeded.
8. Competitors shall not consume or purchase alcohol at the event venues during the tournament. Alcohol will not be served to competitors under or above 18 years old.
9. The Committee may adjust handicaps after each round for the duration of the tournament.
10. Breaches of these conditions may result in appropriate sanctions determined by the Committee, including
